1 Audacity manual

This is a manual for audacity, based on the 1.2.4b-2.1+b1 version from the Debian Edu Etch 3.0 release.

The version at <http://wiki.debian.org/DebianEdu/Documentation/Manuals/Audacity> is a wiki and updated frequently.

Translations are part of the debian-edu-doc package, which can be installed on a webserver, and is available [online](#).

2 Before you start

Setup Audacity is not hard, if you remember to setup that Audacity to use Jack, this is to make it possible to run other program that use sound at the same time. How to setup Jack to run smoothly. The guide is here:

I used Audacity 1.3.3-Beta when i make this documentation.

So to set Audacity to use jack you have to go in the menu --> Edit ---> Preferences.



The next thing you have to be aware of that the project rate must be the same sample rate you have set in jack.

Well you can simply just install it with aptitude, and you can also take a look at the projects page here <http://audacity.sourceforge.net/>

3 Doing some recording

First thing to remember when you do a recording, is that you are careful that the record volume settings, not set to loud. It's better to have to low setting rather to loud on this.



And when you have recorded what you want, you can normalize the recording so the volume automatically set right volume on the record without any danger of have part of the sound overdriven.



And after you have normalized the recorded segment, it looks like this:



Now the volume on this recorded segment is corrected. This is a better way to be sure that the record you have done not are overdriven, so have to Low setting and afterwards let audacity fix the volume on it.

Now we want to remove noise from the record, maybe some background hiss from your microphone. So first part is to make a "noise profile" of what you want to remove from your recorded segment.

1. First zoom out so you more clearly can see the recording.



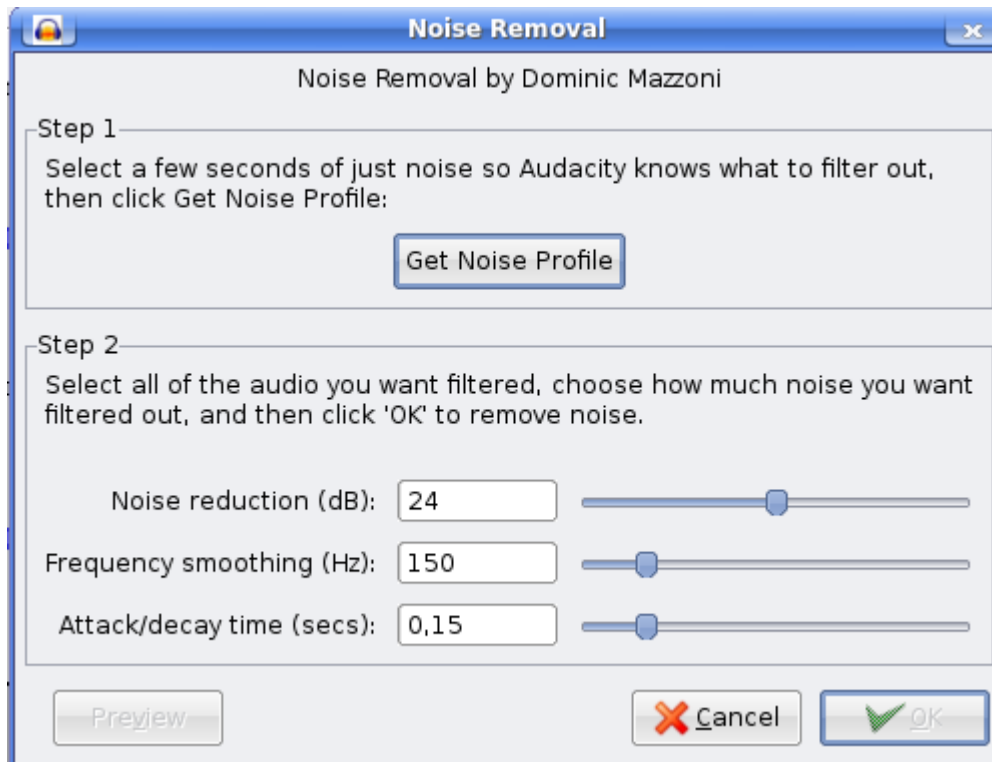
2. Then mark what you want to make a profile of. Buy left click on mouse and hold down on the segment, and drag. You mark the zone you need to get the profile of.



3. Then choose that you want to use Noise removal.



4. Then Create "noise profile".



5. Then you choose the whole record by clicking CTRL + A, and choose noise removal again from menu, but this time press OK.

Then if you want to add some reverb, other nice effects to your liking, you just search the big menu that is available after you installed the plugins I recommended.

You have several way to export your finished result. You can export it as WAV, AIFF MP3, OGG, FLAC, just choose export in the file menu.

4 Importing Audio

With audacity you can import audio of the regular variety: Audio, MIDI, Labels and Raw Data. You can directly import MP3 files into the project, and mixing different song together in audacity.

Let me give you example.

First my main song "smurfesangen", and then you can import for mixing, one another song, just choose in the menu > > file > > Import Audio, then the newly imported audio will come under your first audio, the possibility to mixing here is huge.



5 Tool section

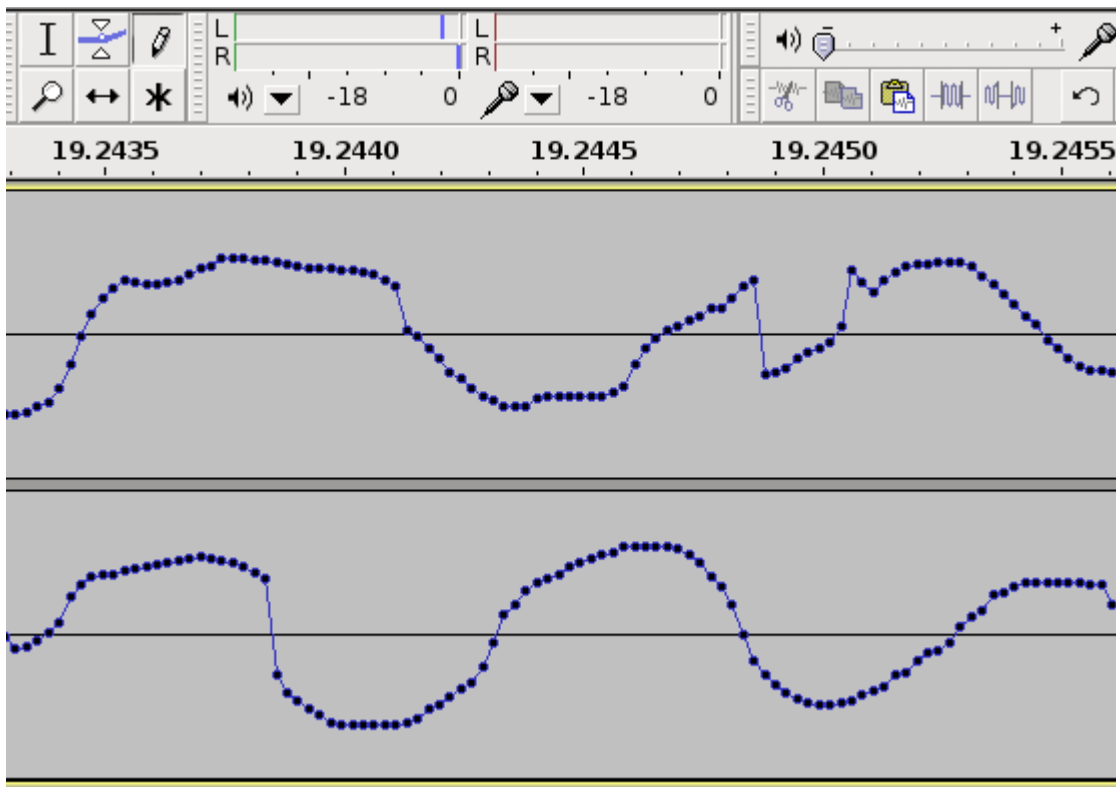


5.1 Selection tool

To split the audio so you can move part of it you have to first with the selection tool, choose where you want to cut it. And then with "ctrl + I" split it. And then with time shift tool you can move the segment.

5.2 Zooming tool

With the Zooming tool you can zoom into the audio segment and then manipulate the audio with the drawing tool.



5.3 Envelope Tool

With the envelope tool you can manipulate the volume by increasing or decreasing the volume wherever you are on the segment.



5.4 Time Shifting Tool

with this you can move your audio segments around.

8.1 Translate using PO files

As in many free software projects, translations of this document are kept in PO files. More information about the process can be found in `/usr/share/doc/debian-edu-doc/README.debian-edu-audacity-manual-translations`. The Git repository (see below) contains this file too. Take a look there and at the [language specific conventions](#) if you want to help translating this document.

To commit your translations you need to be a member of the Salsa project `debian-edu`.

Then check out the `debian-edu-doc` source using ssh access: `git clone git@salsa.debian.org:debian-edu/debian-edu-d`

If you only want to translate, you need to check out only a few files from Git (which can be done anonymously). Please file a bug against the `debian-edu-doc` package and attach the PO file to the [bugreport](#). See [instructions on how to submit bugs](#) for more information.

You can check out the `debian-edu-doc` source anonymously with the following command (you need to have the `git` package installed for this to work):

- `git clone https://salsa.debian.org/debian-edu/debian-edu-doc.git`

Then edit the file `documentation/debian-edu-audacity/debian-edu-audacity-manual.$CC.po` (replacing `$CC` with your language code). There are many tools for translating available; we suggest using `lokalize`.

Then you either commit the file directly to Git (if you have the rights to do so) or send the file to the bugreport.

To update your local copy of the repository use the following command inside the `debian-edu-doc` directory:

- `git pull`

Read `/usr/share/doc/debian-edu-doc/README.debian-edu-audacity-manual-translations` to find information how to create a new PO file for your language if there isn't one yet, and how to update translations.

Please keep in mind that this manual is still under development, so don't translate any string which contains "FIXME".

Basic information about Salsa (the host where our Git repository is located) and Git is available at <https://wiki.debian.org/Salsa>.

If you are new to Git, look at the [Pro Git](#) book; it has a chapter on the [recording changes to the repository](#). Also you might want to look at the `gitk` package that provides a GUI for Git.
